

Minutes of GB Meeting Dated 28th March 2021

The general body (now referred as GB) meeting of Mumbai branch of Indian Association of Physiotherapists was convened by Dr. Maria Jiandani; convener of said branch at 6:00 pm. A notice for which was given in the circular dated 7th March 2021. This meeting was conducted on online platform of zoom in view of COVID 19 pandemic.

Dr. Mariya (L2209) welcomed all those present at the GB meeting. She requested everyone to maintain one minute of silence to offer condolence for late Prof. Hemachandra Jawale (PT). The agenda of the said meeting was read out by her.

1. Dr. Mariya requested Dr. Mayur, EC Member to read the minutes of last GB meeting (23th June 2019). Points arising from said meeting:
 - a. Dr. Ravindran (L9229) suggested one spelling correction in treasurer's report; 'Sending' audited account in place of 'spending' audited accounts.
 - b. Dr. Deepak Kachalia informed that his life membership number is 1043 and not 1042.
 - c. Dr. Mariya suggested one spelling correction in treasurer's report; providing 'facilities' in subsidized rate and not 'faculties'
 - d. Dr. Mariya further informed that MBIAP has received the updated list of IAP members with total 28,000 members; however this list do not identify the members from Mumbai zone and also lack with information of email ID and contact details; making it difficult to reach out to the registered members. Therefore she requested everyone to update MBIAP via email about their registration and contact details and she asked everyone to visit the MBIAP website frequently to keep updated about the event planned.
To this, Dr. Shailesh Hathi said that MBIAP is requesting IAP to provide updated list since 2011 and the registration number in the year 2011 was 23,056; therefore in so many year having only 5000 more registration is not a realistic figure.
Dr. Ravindran informed that MBIAP will write back to EC of IAP asking for Brach Share, Year wise registration, and details of candidates.
 - e. Dr. Mariya informed that IAP has restructured its configuration and has approached MBIAP for a meeting which will be held in a week's time to understand the change in structure and expectations from MBIAP.

As there were no further points arising out of minutes, it was proposed passed by Dr. Sudeep Kale (L19052) and seconded by Dr. Chitra Potnis (L1127)

2. Before presenting convener report, Dr. Mariya informed the House that this GB is for the year 2019-2020, which was supposed to be held in June 2020; however due to COVID 19 pandemic there was delay in conducting the meeting.

 - f) 29th September: Workshop on Neuro developmental Therapy Resource Person: Dr. Sneha Sharvanakumar

She thanked all faculties and resource persons for sharing their knowledge and expertise during these events. She requested Dr. Ravindran to present the treasurer's report.
